



Subject: Regarding availing benefit of 5% Interest Subsidy under Education Loan Scheme of Haryana Women Development Corporation.

Dear Sir,

I would like to draw your kind attention on the subject cited above and to inform that Haryana Women Development Corporation was set up in 1982 under Companies Act, 1956 (amended Act, 2013) with an authorized share capital of Rs.30.00 Crores. The Corporation promotes activities for the welfare, development and advancement of women.

Haryana Women Development Corporation is implementing Education Loan Scheme for providing financial assistance to female students under Bank tie-up Scheme. Due to limited resources of the family, ambitious and meritorious female students are deprived of basic/higher/professional and technical education. To encourage women/girls belong to Haryana State to pursue higher education at Graduate/post graduate/Doctoral/Post doctoral level, the Haryana Women Development Corporation provides 5% interest subsidy on Education Loan. The detailed scheme can be seen on the website ([www.hwdcl.org](http://www.hwdcl.org)) of the Corporation.

For example if a student takes loan from Nationalised/Commercial Banks @ 9.25% interest, the Corporation will provide 5% interest subsidy and remaining interest of only 4.25% will be borne by the student.

I would, therefore, request you to direct all the concerned Universities, Colleges under your Department in the State to publicize the Scheme in their respective areas and also apprise the female students about the benefits of the Scheme, so that the female students who are willing to pursue higher studies may avail the benefit of the Scheme.
